Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of RA 9184 otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino Citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Ms. Maria Christina C. Pabicon, Chairperson BAC Secretariat and inspect the Bidding Documents at CLMMRH, Procurement Office, Bacolod City from 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders from the address stated and upon payment of a non- refundable fee at CLMMRH Cashier.

It may also be downloaded free of charge from the website of the Philippine Government Electronic System (PhilGEPS) and the website of the Procuring entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Bids will be opened in the presence of the bidder’s representatives who choose to attend. Late bids shall not be accepted.

The Corazon Locsin Montelibano Memorial Regional Hospital reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
